IMPORTANT INFORMATION

REMINDER: INTERIM CHANGES TO PRE-HIRE WRITTEN EXAM TAKE EFFECT

The Council held a Special Meeting on June 22, 2021. At that meeting, the Council adopted **interim** changes to the Pre-Hire Written Exam for Local Corrections Officers that is administered by EMPCO. Following is the proposal adopted by the Council:

Beginning August 1, 2021, the following interim changes to the Written Exam for Local Corrections Officers will take effect:

1) The new requirements will take effect on August 1, 2021 and will remain in effect until a final recommendation is approved by the Council.

2) Written Exams taken within one year prior to the effective date will be grandfathered into the new requirements.

3) Taking the Written Exam will still be required **prior to being employed** by a Sheriff's Office.

4) MSCTC will no longer establish a minimum passing score for the Written Exam.

5) Each Sheriff's Office will be responsible for determining the Written Exam minimum passing score acceptable for their agency.

6) There will be no limit on the number of times an individual can take the Written Exam as long as they pay for each exam, and if a higher score is obtained on subsequent testing, the higher score shall be counted.

7) Each Sheriff's Office will be required to maintain a record of the Written Exam score in the personnel file of each Corrections Officer hired after August 1, 2021.

8) Beginning August 1, 2021, each Sheriff's Office will be required to enter into the LCOTS System the Written Exam score for each Corrections Officer hired after August 1, 2021. If a higher score is obtained subsequent to taking a future Written Exam, the Sheriff's Office shall enter the higher score into the LCOTS System within 30 days of posting the new score.

The Council strongly advises that you share this information with your Corporate Counsel/HR Department prior to making any decisions regarding these interim requirements.

Jail Administrator Spotlight

Robert Earle Ingham County Sheriff's Office Jail Administrator

Robert Earle, currently a Captain with the Ingham County Sheriff's Office, attended high school in the suburban Detroit area and went on to study Criminal Justice at Michigan State University. While studying Criminal Justice at Michigan State, he completed an internship at the Macomb County Sheriff's Office and studied abroad at the University of Lviv and the University of Odessa in the Ukraine.



Robert served in many capacities at the Ingham County Sheriff Office starting as a Deputy in the Corrections Division in 2001 before rising to the rank of Sergeant in 2012, to the rank of Lieutenant in 2017 and Captain / Jail Administrator in 2021. He served multiple duties with ICSO including Housing Officer, Work Release Coordinator, Corrections Training Officer, Corrections Hostage Negotiation Team, Booking Officer and Classification Officer. He has been a liaison to the 30th Circuit Court's Mental Health Court and has worked on several inmate initiatives, including an Ingham County program to reduce opioid overdose deaths. He also started an initiative to bring together Mental Health professionals, Jail Medical, Classification and Jail Command officers weekly to address high risk inmates and those suffering from mental and medical health issues.

In 2018, Robert was recognized and awarded the Distinguished Valor Award from the National Institute of Jail Operations (NIJO). The NIJO Distinguished Valor Award is award to those individuals who are recognized for their outstanding service to heroically serve and protect or who has made critical decisions or has taken preventive actions that ensured the safety and security of staff, inmates and the general public. He was recognized at the NIJO Conference in New Orleans in August 2018.

In 2018, taxpayers approved a \$70-million-dollar project to design and build a new Ingham County Criminal Justice Center, which includes a new District Court in addition to a new Law Enforcement and Correctional Facility. Robert was selected to be team leader from the Sheriff's Office and has worked closely with architects and construction managers in the design and construction of this new facility, scheduled to open in Summer 2023.

Robert also developed and teaches Inmate Classification for Macnlow and Associates since 2017.

NCCE certification requires 115 hours of legal-based training within a 30 month period. Due to the degree of scrutiny and litigation correctional officers and



administrators face regularly, NIJO emphasizes the importance of certification programs based on what the law requires rather than best practices that do not promote practices that are constitutionally safe. Because liability and risk management is intertwined with training, NIJO requires 100% comprehension testing for certification. Lieutenant Greenlee's achievement is a significant accomplishment and reflects her commitment and dedication to her profession

JAIL COMMAND STAFF ACADEMY REGISTRATION DEADLINE IS AUGUST 27, 2021

The MSCTC in partnership with and presented by the National Institute for Jail Operations (NIJO), and co-sponsored by the Michigan Municipal Risk Management Association (MMRMA), will host the next Michigan Jail Command Staff Academy (JCSA) beginning September 28, 2021, in Lansing, MI.

Program tuition* is sponsored by the MSCTC with the command curriculum designed by NIJO. Participants that successfully complete this Academy will receive an Academy

Completion Certificate from the MSCTC and the MMRMA, along with approximately 72 credit hours that may be applied toward the NIJO National Certified Correctional Supervisor (NCCS) or National Certified Correctional Executive (NCCE) certifications.

Jail Command Staff Academy courses include leadership, budgeting and RFP, data driven statistics, correctional law updates, proactive liability defense, report writing, investigations, and legal issues.

REMINDER: ACADEMY COMPLETION INFORMATION NOW ENTERED BY MSCTC

Beginning 2021, Local Corrections Officer Academy training information (once approved by the Council), will now be entered into the Local Corrections Officer Tracking System (LCOTS) by the MSCTC. Agencies are now only responsible for entering and maintaining correct and up-to-date in-service training records for their full or part-time Corrections Officers.

REMINDER ABOUT CHANGES TO ANNUAL IN-SERVICE TRAINING REQUIREMENT

Beginning in 2021, the following In-Service Training Requirements took effect:

1) Mandatory two (2) hours per year of Mental Health training must be part of the yearly 20-hour in-service requirement.

2) No more than 5-hours of Firearms Training can be counted toward the 20-hour inservice training requirement.

Please note, according to the American Correctional Association (ACA), the National Alliance on Mental Illness (NAMI), the National Commission on Correctional Health Care (NCCHC), and the National Council for Behavioral Health (NCBH); mental health training for Corrections Officers not only includes courses such as Crisis Intervention Training (CIT) and Mental Health First Aid (MHFA), but also training topics such as interpersonal communication, de-escalation skills, understanding and managing mentally ill inmates, suicide prevention, substance use and abuse, and signs and symptoms of developmental disabilities.



NIJO Legal-Based Jail Guideline: 101.03.03 Laundry and Clothing Issue

KEY ISSUES:

On September 6, 2018 inmate Tyler Tessier, waiting to stand trial for the murder of his pregnant girlfriend, was found dead in his cell hanging from a sheet – just 10 minutes after he picked up his breakfast. Sixty-four days earlier, inmate Thierry Nkusu had successfully used the same approach, also using his bed sheet to hang himself. His death came 48 hours after he was sentenced to life without parole. Following these two suicides, the Montgomery County jails Corrections Director Robert Green began looking for some answers. As part of the solution, they opted to replace all the sheets and double up with blankets. Many jails struggle financially and issuing these items regularly while keeping inmate hygiene, safety and security checked is extremely challenging. It is important for an administration to know when setting policies and procedures governing the issuing of bedding and clothing what is actually required by law and what isn't.
