IMPORTANT REMINDER TO SUBMIT YOUR IN-SERVICE TRAINING WAIVER REQUEST ASAP!

With 2021 now behind us, it is important to submit Waiver Requests for your Corrections Officers who have not completed their 2021 In-Service Training requirement. The requests should be submitted to our office at your earliest convenience in order to be considered at the April 26, 2022 Council meeting.

If you have a Corrections Officer on your LCOTS roster who has not completed their minimum 20-hours of In-Service Training, which includes at least 2 hours of Mental Health training, and a Waiver Request Form is not submitted, your county will not receive a 2021 100% Compliance Certificate.

Reminder: In order for your Corrections Officers to be in compliance with having at least 2 hours of mental health training each year, the training must be recorded under the "Mental Health" category in the LCOTS system. If the training is not recorded under "Mental Health", it will **not** be recognized as meeting the requirement.

TWO IMPORTANT REMINDERS REGARDING LOCAL CORRECTIONS OFFICERS

Corrections Officers and The LCOTS System

When a Corrections Officer is hired in your agency, whether a brand-new hire or a transfer from another Sheriff's Office, it is important to make sure that person is entered into the LCOTS system.

For a brand-new Corrections Officer, you must first log-in to the LCOTS System, then follow these steps:

- 1. Select "Enter New Officer" and complete all requested information.
- 2. Select "Add Officer To Data Base".
- 3. Select "Add Officer To Your (agency) Roster" and complete all requested information.
- 4. Select "Confirm Roster Entry".

For a Local Corrections Officer that may have transferred from another agency, you must first log-in to the LCOTS System, then follow these steps:

- 1. Select "Add Officer To Your (agency) Roster" and complete all requested information.
- 2. Select "Confirm Roster Entry".

It is important to follow these steps to ensure the Corrections Officer becomes part of your

agency's Roster.

Time Frame to Complete a Local Corrections Officer Academy

Once hired by a Sheriff's Office, a Corrections Officer has one (1) year from their **original** hire date to complete the Local Corrections Officer Academy. An example: if a Local Corrections Officer is hired by another Sheriff's Office on May 10 of 2022, and is then hired by your agency in September, 2022, the one (1) year requirement begins in May, 2022, **NOT September, 2022**, so your agency would have to send the officer to a Local Corrections Officer Academy no later than May 10, of 2023.

Remember, it's always one (1) year from the original date of hire.

MSCTC On-Line In-Service Training DACOTA Spotlight – April 2022

Through a training partnership with MSCTC, the National Institute for Jail Operations provides Michigan agencies with engaging legal-based online training through DACOTA —NIJO's Detention and Corrections Online Training Academy. All DACOTA curriculum is approved for all levels of <u>NIJO Professional Certification</u> (NCCO, NCCS, and NCCE).

Currently, the DACOTA Catalog contains 69 online courses providing 75 CEUs of corrections-specific training based on what the law requires for running safe and secure facilities. As of the end of February 2022, Michigan DACOTA online learners have completed 1,152 courses and 1,281 credit hours. As of the end of the February, 30 Michigan agencies have learners getting trained in the DACOTA platform. HOW STAFF TRAINING CAN IMPROVE AGENCY RETENTION

Trained employees feel they have been 'invested in' by their Agency and are able to complete their job assignments with more confidence. Lasting self and Agency improvements are directly related to quality training. Individual growth, personal goal setting, and an alliance with Agency values has also been seen with excellent training. Improvements such as these, directly lead to the increased work performance and job satisfaction that is needed to create staff retention. Training can be used for motivation, boosting morale, liability protection, and continued Corrections advancement. Encouraging training outside of State and Agency requirements indicates the Agency is invested in their employees and wants them to succeed. Perks such as gift cards donated from local businesses can be used to reward those that train above the set requirements. In-service and Academy training should not just be done to check off the requirements box, training should also be conducted to inform and aide in the learning and growth process of Sheriff's Office Corrections Officers which cultivates staff retention. The Michigan Jail First Line Supervisory Academy (MJFLSA) is a tuition FREE* intensive 32- hour correctional academy developed specifically for the First Line Supervisor and approved by the Michigan Sheriff's Coordinating and Training Council. The curriculum, designed and facilitated by the National Institute for Jail Operations, engages attendees to learn and apply these eight core management topics:

- Decision Making for First Line Supervisors
- Supervisor Report Writing and Litigation Preparation
- In-Custody Death and Response
- Proactive Liability Defense: Use of Administrative Segregation
- Leadership
- Personnel Management
- Communication and Relationships in the Work Setting

NIJO Legal-Based Jail Guideline:

D06.01.01 – Disciplinary Policy & Procedure Violations

KEY ISSUES:

"Why don't you try to make me?"

"No, I am not going to do that, not now, not ever."

The long list of negative inmate responses to disobey regulations and officer commands are well known and rehearsed to every correctional officer. One of the chief cornerstones required for effective inmate management is inmate discipline. Because inmates are persons who are convicted of or accused of violations of criminal law, it is obviously necessary to have punishment as an available option to encourage or coerce inmates to comply with inmate rules and regulations that might not otherwise be followed. However, inmate discipline can only happen when officers and inmates know the expectations, policies, procedures and process.

There are over a dozen<u>NIJO Legal-Based Guidelines</u> which are focused on inmate discipline; however, learn more about some operational practices that are worth highlighting.
