MSCTC TUITION FREE* MICHIGAN JAIL FIRST LINE SUPERVISORY COURSE OFFERED!

The Michigan Jail First Line Supervisory Academy (MJFLSA) is a tuition FREE* intensive 32- hour correctional academy developed specifically for the First Line Supervisor and approved by the Michigan Sheriff's Coordinating and Training Council. The curriculum, designed and facilitated by the National Institute for Jail Operations, engages attendees to learn and apply these eight core management topics:

- Decision Making for First Line Supervisors
- Supervisor Report Writing and Litigation Preparation
- In-Custody Death and Response
- Proactive Liability Defense: Use of Administrative Segregation
- Leadership
- Personnel Management
- Communication and Relationships in the Work Setting
- Employee Wellness & Peer Support Groups

The first 16 hours of this 32-hours course is scheduled to be held on October 5 and 6, 2022, in Lansing, MI. The final 16 hours of this 32-hour course is scheduled on October 26 and 27, 2022, in Lansing, MI. Attendance at both sessions is required to successfully complete and graduate from the Michigan Jail First Line Supervisory Academy.
